**Re: You are entitled to part of the information you requested – 2021-00653-JUS**

Justice received your application for access to information under the *Freedom of Information and Protection of Privacy Act* on April 6, 2021.

In your application, you requested a copy of the following records:

*I am requesting statistics on the number and length of lockdowns in your correctional institutions. (Date Range for Record Search: From 02/29/2020 To 03/30/2020)*

You are entitled to part of the records requested. However, we have removed some of the information from this record according to subsection 5(2) of the *Act*. The severed information is exempt from disclosure under the *Act* for the following reason:

1. Section 20: Information that would be an unreasonable invasion of the privacy of individuals named in the records.
  - (a) Section 20 (1) The head of a public body shall refuse to disclose personal information to an applicant if the disclosure would be an unreasonable invasion of a third party's personal privacy

Note that in the Ethnic Origin Summaries if there were five or fewer people within an identified ethnic group the number was withheld as they could potentially identify an individual.

The department would like to provide the context that a lockdown generally refers to a larger group whereas close confinement is the result of a lockdown.

The remainder of the records are enclosed.

You have the right to ask for a review of this decision by the Information Access and Privacy Commissioner (formerly the Review Officer). You have 60 days from the date of this letter to exercise this right. If you wish to ask for a review, you may do so on Form 7, a copy of which is attached. Send the completed form to the Information Access and Privacy Commissioner, P.O. Box 181, Halifax, Nova Scotia B3J 2M4.

Please be advised that a de-identified copy of this disclosure letter and the attached response to your FOIPOP application will be made public after 14 days. The package will be posted

online at <https://openinformation.novascotia.ca/>. The letter will not include your name, address or any other personal information that you have supplied while making your application under FOIPOP.

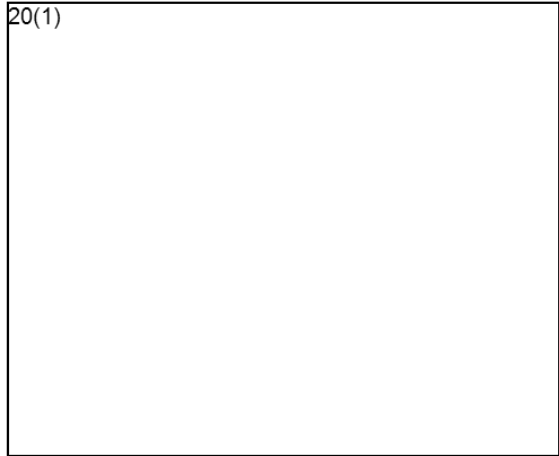
