Hi Chris,

As the staff employed at the Section 81 and 84 facilities are not employed by CSC, Leah confirmed that she has not had any discussions with AHS on their vaccine eligibility, however would anticipate they will fall under congregate living circumstances.

Also, within Alberta, FN/Metis/Inuit born in 1972 or earlier are currently are eligible to schedule vaccine appointments. I would anticipate that SDHC and BSWH would both fall under Phase 2C based on the descriptors, and similar to correctional facilities and other congregate living situations. They could obtain patient specific vaccination appointments sooner based on AHS criteria.

I can reach out to the Directors of the facilities to inquire if they have been contacted directly by AHS.

Booking March 10

- Albertans 75+ (born 1946 or earlier)
- AstraZeneca: Born 1957 or FNMI born 1972

Coming soon

- AstraZeneca: Born in following years
- Phase 2A opens March 15 by birth year, starting with 1947 or FNMI born 1962

Good Afternoon Jenn,

I'm hoping to finalize the number of beds this afternoon. There are no CSC nurses on site at either Buffalo Sage or Stan Daniels. Rather, there are Nu Hos at Grierson which is on the same property location in Edmonton. Section 81 patients attend Grierson for health service provision. I completed this amendment on the attached.

BSWH has a total capacity of 28 with fluctuating Sec 81 and 84 capacities. Currently we have 11 Section 84 and 8 Section 81 there.

SDHC has a total capacity of 73 with again, fluctuating Sec 81 and 84 capacities. Currently we have 15 Section 81 and I am waiting to hear back on the Section 84s.
