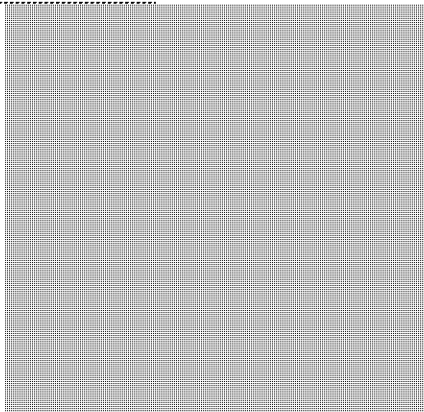

Good morning,

Could I ask that you forward the names of the physicians who have signed the COVID Vaccine Medical Directive. If NMAC is supportive CSC will offer an extra dose if achievable to a patient. Clearly these patients would not receive their second dose till well beyond the 42 days. This may put the physician who has provided the approval at legal risk. CSC will in all likelihood indemnify these physicians as CMPA may not provide coverage in this case. If we could have the list by end of Tuesday this would be much appreciated,
