Good evening,

PDYC continues to be on OUTBREAK status to 09-May-22 which will need to be reassessed in consultation with public health.

U7 - is on QUARANTINE as close contacts with a positive staff (as per public health). All youth are POCT-negative and PCR-tests have been completed and sent to the lab.

U3 - ISOLATION - 1 PCR-positive youth on remains symptomatic, 2 others remain asymptomatic. 3 PCR-negative youth continue to be POCT-negative and asymptomatic. ISOLATION end date is 24-Apr-22.

U4 - ISOLATION - 2 PCR-positive youth are still symptomatic and remain on ISOLATION. 2 PCR-positive youth are asymptomatic. End of ISOLATION is tentatively 21-Apr-22.

U5 - ISOLATION - 1 POCT-positive youth is symptomatic and we are still waiting for PCR results. End date TBD.

After PCR tests the first three youth are positive (two symptomatic) and will remain on isolation status until 24-April-2022, or asymptomatic free for 48 hours.

As there are two symptomatic positive youth this will impact our OUTBREAK end date (still to be determined).

The second set of youth were PCR negative and will be quarantined on the Unit until 24-April-2022. They will be monitored for symptoms.

Good afternoon everyone!

U3 has been placed on Covid-19 **isolation**.

- We have 3 youth who have been rapid-tested (POCT) and are positive, two are presently symptomatic, one asymptomatic.
- There are 3 additional youth on the Unit who are showing POCT-negative and remain asymptomatic.
- All youth have been PCR swabbed and our nurses are awaiting results from the lab. We will update you, once PCR results are received.

Further consultation will occur with Public Health, regarding extension of our OUTBREAK status end date, which was previously anticipated as 09-May-2022.
