I am requesting statistical overviews broken down by race and gender that track COVID-19 cases amongst prisoners and prison staff, including positive tests, negative tests, inconclusive tests, deaths, recoveries and active cases, as well as memorandums and presentations on these statistics. Timeframe 2 (first 6 months): 1 March 2020 to 30 August 2020.

On March 17, 2021 our office advised you the request had been placed on hold, pending clarification of the request details.

Testing

I am requesting statistical overviews broken down by race and gender that track COVID-19 cases amongst prisoners and prison staff, including positive tests, negative tests, inconclusive tests, deaths, recoveries and active cases, as well as memorandums and presentations on these statistics. *1 March 2020 to 31 August 2020.*

On April 19, 2021 our office advised you that the 30-day response period has been extended an additional 30 days, and a response would be provided by May 19, 2021.

This is to inform you that your access request has been fully granted.
