Justice received your application for access to information under the *Freedom of Information and Protection of Privacy Act* on April 9, 2021.

In your application, you requested a copy of the following records:

*I am requesting statistics for the number of temporary absences, paroles and all releases from your correctional institutions related to COVID-19 pandemic prevention and management.
(Date Range for Record Search: From 02/29/2020 To 03/30/2020)*

You are entitled to part of the record(s) requested. However, we have removed some of the information from this record according to subsection 5(2) of the Act. The severed information is exempt from disclosure under the Act for the following reason(s):

- Section 15: information related to law enforcement and security.
- Section 20: unreasonable invasion of personal privacy.

The remainder of the records are enclosed.

You have the right to ask for a review of this decision by the Information Access and Privacy Commissioner (formerly the Review Officer). You have 60 days from the date of this letter to exercise this right. If you wish to ask for a review, you may do so on Form 7, a copy of which is attached. Send the completed form to the Information Access and Privacy Commissioner, P.O. Box 181, Halifax, Nova Scotia B3J 2M4.

Please be advised that a de-identified copy of this disclosure letter and the attached response to your FOIPOP application will be made public after 14 days. The letter will not include your name, address or any other personal information that you have supplied while making your application under FOIPOP.

You have the right to ask for a review of this decision by the Information Access and Privacy Commissioner (formerly the Review Officer). You have 60 days from the date of this letter to exercise this right. If you wish to ask for a review, you may do so on Form 7, a copy of which is attached.
