Alain,

Can we discuss? I am not familiar with how long IEDM spend in the institution and I am not sure that vaccinating them would change the need to do things by video if possible. The public health messaging right now is that public health measures should not change, even if you are vaccinated so we would likely recommend that even once we are vaccinated we do as much remotely as possible. No vaccine is 100% effective and there are concerns over the variants so until we have herd immunity as a country (the fall) the risk is still high.

To date, the only non-CSC people we were planning to vaccinate are those who cannot work remotely – physicians/dentists, elders, chaplains.
